2. The total SCPA/Mark secured by each successful candidate is shown along with the Register number of the candidate.
3. In the case of First Degree Programme under CBCSS and CSS, for the successful completion of a Semester, a candidate has to score a minimum SCPA of 4.00 (E Grade). A minimum of 40% marks (E Grade) is required for passing a course with a separate minimum of 35% (E Grade) for End Semester Evaluation (ESE) and for Continuous Evaluation (CE) for candidates of 2015 Admission onwards and with a separate minimum of 40% (E Grade) for End Semester Evaluation (ESE) and for Continuous Evaluation (CE) for 2014 Admission.

4. In the case of Post Graduate Examination for successful completion of a semester, a candidate shall secure a minimum of 40% marks for ESE and 50% marks for CE and ESE together for each subject in the semester for candidates belonging to 2015 Admission onwards. For candidates of 2014 admission a minimum of 30% marks for ESE and 40% marks for ESE and CE together is required for a Semester / Course pass. No separate minimum is required for CE marks.
5. The draft Statement of Marks will be obtained from the College Website shortly.
6. The Consolidated Result of FDP & PG Degree Courses will be notified shortly.
7. Application for Scrutiny / Revaluation of Marks shall reach the Office of the Controller of Examinations, in the prescribed form along with fees, within 15 days from the date of publication of statement of marks. No Revaluation is applicable for P.G. Degree Courses.
8. Students who apply for scrutiny shall have to submit application for revaluation of answer scripts within 5 days from the date of scrutiny of their answer scripts.
9. The form of Application and the fee for Scrutiny / Revaluation is available at the College Office.
10. Candidates who are eligible for Grace Mark in any area of Excellence should submit the application duly certified and recommended by concerned Co-ordinators and Principal to the Office of the Controller of Examinations on or before 14.06.2018.
11. Candidates who have not submitted the copy of the pass certificates of Standards 10 & 12 for name verification should submit the same in the Office of the Controller of Examinations immediately.
