4. Candidates provisionally selected for admission for all programmes should appear for an interview at the Principal's office. Selection will be finalised only after the interview. **The Principal reserves the right to refuse admission to any applicant, if found ineligible for admission according to the regulations of the University and the Management.**
5. The applicant must be accompanied by his/her parent(s) at the time of the interview and should produce the following documents:  
Applicants should produce the following documents at the time of interview:
  - a. Two copies of the Admission Memo.
  - b. Printout of completed online application.
  - c. Printed copy of the downloaded Application form, two copies of the Bio-data form, Anti-ragging form and PTA form.(double sided printout in A4 paper)
  - d. Original T.C, Course & Conduct certificate from the institution last attended
  - e. Original Mark list of the qualifying examination along with one self-attested copy of the same.
  - f. Certificate to prove date of birth (Two self-attested copy of Class 10 Certificate)
  - g. Eligibility Certificate in the case of candidates other than Kerala HSE/VHSE/CBSE/ISC.
  - h. Migration Certificate, if applicable, and one self-attested copy of the same.
  - i. Community certificate from the Parish priest and Catechism certificate for Malankara Catholic candidates.
  - j. Caste / Community / Income Certificates for Reservation / Fee concession candidates from the concerned authority. Certificates more than a year old will be considered invalid.
  - k. Original and a self-attested copy of NCC / NSS / SPC / Scouts & Guides certificate, if applicable.

- l. Children of Ex-Service personal / Jawan should produce the concerned certificate
- m. SC / ST / OEC candidates – Community / Caste certificate from Tahsildar / Village Officer. Certificates more than a year old will be considered invalid, unless mentioned otherwise in the certificate.
- n. PWD (Person with disability) candidates should produce the medical certificate with 5 year validity. (Refer Page No.19&20 of the UG Prospectus 2022).
- o. Non Creamy layer Certificate in case of SEBC (Refer Annexure 5 of the UG Prospectus 2022) candidates claiming vacant SC/ST seats.
- p. Course cancellation memo, if applicable.
- q. Any other relevant certificate for any claim made in the application
6. Admitted students should pay the fees for their Diploma/Certificate course chosen. There will be a PTA collection for college development at the venue.
7. Since the admitted students should submit the original Plus Two/VHSE/CBSE/ISC certificates in the college at the time of admission, students are advised to keep enough attested copies of the same for their future use.
8. It is mandatory that one of the parents must be present with his/her son/daughter at the time of interview. Under any circumstances if either of the parents is not in a position to attend the interview, the matter will have to be communicated to the Principal by email or in person and permission in this matter has to be obtained before the interview.
