

This Prospectus contains general information and rules relating to admission to the Four Year Under Graduate Programmes [FYUGP] in Mar Ivanios College (Autonomous) for the academic year 2025-26. It consists of three sections: i) General information about the programmes offered by the College and the basic rules of the College; ii) Admission Regulations relating to the admission to the Four Year Under Graduate Programmes [FYUGP]; iii) A special notice on Ragging as a Criminal Offence.

Applications are invited for candidates to be admitted to the Four Year Under Graduate Programmes [FYUGP] in the Faculties of Arts, Science and Commerce in Mar Ivanios College. The FYUGP leads to a 3 Year UG /4 Year UG (Honours)/4 Year UG (Honours With Research) Programmes in the relevant subject.

Interested students may apply ONLINE in the college website www.mic.ac.in. Last date of Registration of Online Application is 31.05.2025 (Subject to change). Please read the Prospectus carefully before starting the application process.

1. GENERAL INFORMATION

The Four-Year Undergraduate Programmes (FYUGP) is launched in recognition of the requirement to strengthen undergraduate education. The curriculum of the programme are designed to equip students with the knowledge base, intellectual abilities, multidisciplinary perspectives, flexible skill sets, basic expertise, social commitment and research aptitude that will make them responsible citizens in a knowledge society and offer them multiple opportunities in research and employment. The Programme of study shall be by regular attendance for the requisite number of lectures, practical training, tutorial, extension activity and other academic requirements: Building Kerala as a People Centered Knowledge Society • Student Centric Approach • Credit and Semester System • Flexible Learning Pathways • Courses shall be Chosen from Science, Humanities and Commerce Streams • Simplified Examination System • Course Design by Teachers, Industrial Experts and Academic Experts

1.1 About FYUGP

The FYUGP has a student centric approach in which the student can choose their own pathway for learning. On successful attainment of 133 credits* in a three-year period, a student shall be awarded an Under Graduate Degree. In a four-year period, the student can successfully attain 177 credits and shall be awarded with either Undergraduate Honors Degree or Undergraduate Honors with Research Degree. The students can acquire credits through the following categories of courses (subjects).

*'Credit' means the value assigned to a course which indicates the level of instruction; One-hour lecture per week equals 1 Credit, 2 hours practical class per week equals 1 Credit.

1. Discipline Specific Core (DSC) Courses (4 Credits Each)

DSC courses are the core credit courses in a particular discipline. Students may choose DSC courses as their major or minor course of study.

2. Discipline Specific Elective (DSE) Courses (4 Credits Each)

DSE courses are a pool of credit courses in a particular discipline. These courses offers specialisation to students in a particular discipline. It can be a major or minor course of study.

3. General Foundation Courses

It is mandatory for all the students who enroll for a four-year UG programme to acquire 39 credits from 13 general foundation courses which are classified into four different sub categories. Each general foundation course has 3 credits. The general foundation courses should be completed in the first three years of FYUGP.

i. Multi-Disciplinary Courses (MDC) (3 Credits Each)

MDC are Generic Elective courses meant to ensure multi-disciplinary/interdisciplinary education to students. Every Discipline offers MDCs.

In the first three semesters of the FYUGP, the student shall study one Multi-Disciplinary Course (MDC) each from a discipline other than the Major disciplines already chosen. The first and second MDC (MDC1 and MDC2), respectively in the first and second semesters, will be offered by all departments. The third MDC (MDC3) in the third semester is common to all the students, with Kerala-specific content (KS) offered by English/Other Languages. Each MDC has 3 credits. Total 9 credits shall be earned from MDC.

ii. Ability Enhancement Courses. (AEC) (3 Credits Each)

AEC are courses offered by language and literature disciplines to ensure enhancement of language proficiency among students.

The four Ability Enhancement Courses (AEC) will be offered by English and Other language departments. Out of the total 4 Courses, the student has to choose two from English department and the remaining two from any of the other languages department (Malayalam, hindi, tamil,Syriac and french).

iii. Value Addition Courses (VAC) (3 Credits Each)

VACs are meant to inculcate ethics, constitutional values, soft skills, sports, NSS, NCC and such similar values to students. Every discipline may offer VACs. There will also be a common basket of VACs

iv. Skill Enhancement Courses (SEC) (3 Credits Each)

SEC are skill based courses in all disciplines which may inculcate skill, competencies and hands on training. SEC shall be offered by all Disciplines.

1.1.1 Exit Points and Credit Requirements

On Completion of 3 Years (6 Semesters) the student has an option to exit the programme with 133 credits and shall be awarded with a Bachelors degree. The Maximum credit a student can acquire in three year period is limited to 150. Students who secure at least 75% of marks in all the six semesters can choose Undergraduate Honours with Research stream in the fourth year. On Completion of 4 years of study (8 Semesters) by acquiring 177 (maximum of 200) credits the student shall be awarded with a Bachelors (Honours) Degree or Bachelors (Honours With Research) Degree. Fast Track Degree achievement in 5th Semester (2 ½ years) is possible by pursuing Online courses in all the first five semesters for a maximum of 7 credits in each semester and once the same is approved by the respective Board of Studies. The switching of Major is permissible during the 3rd semester. For inter disciplinary (Double Major) programme, student can opt two majors and one minor which will be treated as single discipline. No change in nomenclature of the programme as in the previous year.

- b. Bachelor of Arts (Honours) for those who have scored less than 75% of marks in the first 6 semesters and completed 4 years Degree program.
 - Eg:- B.A. (Honours) English Language and Literature.
- c. Bachelors (Honours With Research) for those who have scored 75% or more in the first 6 semesters and completed 4 year Degree program.
 - Eg:- B.A. (Honours With Research) English Language and Literature.

Duration of the Programme: 3 Year UG / 4 Year UG (Honours)/ 4 Year UG (Honours with Research)

Age limit: The maximum age limit for admission to the UG programme shall be 23 years as on 1st June of the academic year (2025-26) for General/SEBC candidates and for SC/ST candidates, the age limit is 25 years.

**BA (Analytical Economics) is designed with the following two main features: The syllabus is structured in such a way to make the students academically competent and skill equipped to appear for the Civil Services Examinations conducted by the UPSC. Additional training for Civil Services Examinations by experts in the field will also be arranged along with the programme. For those who wish to pursue their PG/Research in the field of Economics after this programme, the additional skill courses in mathematical and statistical tools, basic Econometrics, along with the data science modules for Economics will be added advantages.

****BSc (Statistics): Modern times is an age of big data and there is increasing demand for professionals for processing and analyzing data in big quantum and extracting valuable inputs for successful decision making, through an advanced blend of statistical and computational tools. The BSc (Statistics) programme will include additional courses in Computer Science, Statistics, and Big Data Analytics, which will be designed to train the students for the highly employable skills in Data analysis. Adequate Discipline Specific Elective (DSE) specialisation courses will be provided in Data Analytics and hence the students will be able to acquire 3 Year/4 Year (Honours) UG degree majoring in Statistics with specialisation in Data Analytics.

2.1 FEE CONCESSION (Only for Aided Programmes)

4. ADMISSION REGULATIONS & GUIDELINES

4.2.2 ADMISSION PROCESS

Any candidate seeking admission in Mar Ivanios College (Autonomous) to any FYUG Programmes should compulsorily register online through the College website before the last day of registration for application, irrespective of the category (General/ SC/ ST/ Community (Malankara Syrian Catholic)/ Management/ Candidates from Union Territory of Lakshadweep/ Jammu and Kashmir/ Inmates of Government Children's Home/ Persons with Disabilities (Differently-abled persons)/ Widows/ wards of Armed Forces Personnel, killed or disabled in action during peace time/ Sports etc.) to which he/ she belongs. There is no other mode of registration for admission.

- i. Candidates seeking admission through Management quota to any Programme should also apply in the online mode and should specifically indicate their preference.
- ii. Malankara Syrian Catholic students, who wish to be considered for Community Merit Quota should apply online and bring a letter from the Parish Priest along with the application form to the interview, if they are called for it.
- iii. While making enquiries, please quote your application number, name of applicant and programme applied for.
- iv. Students applying for B.Com (Accounts & Audit) (Self- Financing), should appear for an Entrance Examination, the date of which shall be intimated to the applicants by email/SMS or through the admission portal of the College website. Due weightage will be given to marks obtained in the Entrance Examination along with plus two marks (50:50)
- v. Candidates provisionally selected for admission for all programmes should appear for an interview at the Principal's office. Selection will be finalised only after the interview. The Principal reserves the right to refuse admission to any applicant, if found ineligible for admission according to the regulations of the University and the Management.
- vi. The applicant must be accompanied by his/her parent(s) at the time of the interview and

should produce the following documents:

- a. A printed copy of the downloaded Admission Memo.
- b. Printed copy of the downloaded Application Form.
- c. The Transfer Certificate in original.
- d. The original Pass certificate and mark list of the qualifying examination.
- e. Candidates from Universities/ Boards other than Kerala should produce Migration Certificate and **Eligibility Certificate** in the case of candidates other than Kerala HSC/VHSC, CBSE & ISC.
- f. Certificate of character and conduct from the Head of the Institution last attended.
- g. Malankara Syrian Catholic students should produce Character and Catechism certificates from their parish priest.
- h. Two copies of recent passport size photograph, and the copy of the qualifying examinations passed (S.S.L.C / 10th & Plus two)
- S.C./S.T./O.E.C. candidates should produce recent (with one year validity) community certificate from the Tahsildar/ Village Officer and O.B.C. candidates should produce community and income certificates from the Village Officer.
- vii. Those who are granted admission should pay the fee immediately. The amount to be paid at the time of enrolment is shown in the Fee Schedule/ Admission Memo.
- viii. Seats are reserved for outstanding performers in the field of sports and for differentlyabled persons as per University regulations
 - ix. Parents or guardians of the admitted candidates are expected to join the Parent-Teacher Association of the College.
 - x. All candidates for admission must acquaint themselves with the rules and regulations of Mar Ivanios College and will be bound by them, if admitted.

4.2.3 ELIGIBILITY FOR ADMISSION

4.2.3.1 BASIC ELIGIBILITY

Eligibility for admissions and reservation of seats for various FYUG Programmes shall be according to the rules framed by the University/ College from time to time ("Notwithstanding anything contained in the University Statutes, the selection of students shall be governed by the rules prescribed by the Government from time to time with the concurrence of the University in respect of such admissions").

No student shall be eligible for admission to a FYUG Programme in any of the discipline unless he/she has successfully completed the examination conducted by a Board/University at the Plus two/ Higher Secondary level of schooling or its equivalent. That is, a candidate must have "a pass in Higher Secondary Examination/Vocational Higher Secondary Examination of the Government

of Kerala or an Examination accepted by the Academic Council (of Kerala University) as equivalent thereto"

Admissions to the seats to be filled by the College to the FYUG Programmes are regulated on the basis of marks obtained in the qualifying examination. The allotment of the candidates to the various Programmes will be on the basis of merit/ marks strictly following the rules and regulations regarding reservation.

Admission to B.Com (Accounts & Audit) (Self-Financing) will be on the basis of marks in the qualifying examination and an Entrance/Aptitude Test on 50:50 basis.

4.2.3.2 NATIVITY

All candidates applying for admission to Mar Ivanios College should be citizens of India. All such candidates are categorized as KERALITE or NON-KERALITE.

A candidate of Kerala origin will be categorized as a KERALITE. Children of All India Service Officers allotted to Kerala Cadre are deemed to be Keralites as per G.O. (Rt) No.822/08/H.Edn dated 9-5-2008. But they will not be eligible for communal/special reservation.

A candidate who does not come under Keralite category will be categorized as NON- KERALITE. Such a candidate will be eligible for admission only after all the applicants of Keralite origin are ranked and allotted.

In order to prove that a candidate is an Indian citizen of Kerala origin for the limited purpose of eligibility for admission, he/she has to produce any one of the following certificates at the time of admission.

a. In the case of candidates who have undergone schooling in Kerala, a course certificate from the head of the educational institution last attended in Kerala, certifying that the candidate has undergone his/her studies in Kerala for not less than 3 (three) years within a continuous period of 12 (twelve) years.

OR

b. A certificate from the Village Officer/ Tahsildar to show that he/she or his/her mother/father was born in Kerala.

OR

c. Certificate from the Village Officer/Tahsildar to the effect that the candidate has been a resident of Kerala State for a period of five years within a continuous period of twelve years

OR

d. The true copy of relevant page of Secondary School Leaving Certificate showing the candidate's Place of Birth in Kerala.

OR

e. The true copy of the relevant page of the Secondary School Leaving Certificate showing

Place of Birth in Kerala of either of the parents of the candidate with corroborative certificate to establish the relationship between the parent and the candidate.

OR

f. The true copy of the relevant page of the Passport of the candidate, issued by the Government of India, showing Place of Birth in Kerala or of either of the parents of the candidate showing Place of Birth in Kerala with corroborative certificate to establish the relationship between the parent and the candidate.

Non-Keralites should furnish a copy of the Certificate of nativity from the revenue authority or local body concerned at the time of admission.

5. AGREEMENT FOR DIRECT PAYMENT: RELEVANT PROVISIONS FOR ADMISSION TO THE VARIOUS PROGRAMMES INAIDED COLLEGES

As per Article 18 of the Agreement for Direct Payment entered into between the Government and the Educational Agencies of Private Colleges, admission of students to Mar Ivanios College shall be on the following basis:

- 1. Twenty percent of the total number of seats shall be reserved for students belonging to the Scheduled Castes (15%) Scheduled Tribes (5%). Those seats which cannot be filled on this basis shall be filled on the basis of University/ Government rules;
- Ten percent of the seats shall be reserved for the candidates belonging to Malankara Syrian Catholic community. These seats will be filled strictly on the basis of merit from among the students of the MSC community.
- 3. Fifty percent of the seats will be filled by open selection on the basis of merit.
- 4. The remaining seats (20%) will be filled by the management of Malankara Syrian Catholic Colleges with candidates of their choice.

5.2.2 CATEGORIZATION OF SEATS

In due consideration for the Direct pay agreement mentioned in Section 2.4.1, seats available in the College is mainly classified as Merit Seats, Community Seats, Management Seats and Reservation Seats.

- a. MERIT SEATS: The seats that are filled by the College purely on the basis of merit are classified as "Merit Seats". All candidates applying will come under general merit seats.
- b. COMMUNITY SEATS: The seats that are filled by the College on the basis of merit among candidates of their community (Malankara Syrian Catholic), are classified as "Community Seats".
- c. MANAGEMENT SEATS: The seats that are filled by the Management are classified as "Management Seats".
- d. RESERVATION SEATS: The seats which are earmarked for SC/ST/PWD/ Sports

persons are classified as "Reservation Seats".

5.2.3 RESERVATION OF SEATS

A candidate can claim only any one of the reservation benefits/ seats from within any one the types listed below.

5.2.4 TYPES OF RESERVATION

Seats will be reserved for the following categories for various FYUG Programmes:

- a. RESERVATION FOR NOMINEES
- b. RESERVATION FOR PERSONS WITH DISABILITIES
- c. RESERVATION FOR TRANSGENDER CANDIDATES
- d. SPECIAL RESERVATION AND
- e. MANDATORY RESERVATION

a. RESERVATION FOR NOMINEES:

RESERVATION FOR CANDIDATES FROM UNION TERRITORY OF LAKSHADWEEP.

An additional seat shall be created for each FYUG Programme (wherever necessary), exclusively for the purpose of accommodating students sponsored by the Union Territory of Lakshadweep. This seat shall not be filled up by other candidates (Govt. letter No.5455/b3/2006/H.Edn. dated 15-03-2006)(U.O. No. AcB/1/1134/2006 dated 26-4-2006).

CONCESSION FOR WARDS OF KASHMIRI MIGRANTS

The following relevant concessions are applicable for wards of Kashmiri Migrants for admission to the UG programmes - U.O.No.Ac.B1/910/ Admns/2012, dated 09/04/2012.

- Extension in date of admission by about 30 days.
- Relaxation in cut off percentage up to 10% subject to minimum eligibility requirement.
- Increase in intake capacity up to 5% course wise.
- Waiving of domicile requirements.
- Facilitation of migration in second and subsequent years

RESERVATION FOR CANDIDATES FROM JAMMU & KASHMIR

Two seats shall be created over and above the sanctioned strength to accommodate candidates belonging to Jammu & Kashmir for admission to UG programmes as per UO No. Ac B1/2292/Adms/2012 dated 01.03.2013.

RESERVATION FOR INMATES OF GOVERNMENT CHILDREN'S HOME

One seat shall be created over and above the sanctioned strength for Inmates of Government Children's Home and Establishment as per UO.No. Ac B1/055682/2012 dated 30.04.2013

RESERVATIONFOR TAMIL LINGUISTIC MINORITY

There is no reservation for Tamil Linguistic Minority in Mar Ivanios College

RESERVATION OF SEATS FOR THE WIDOWS /WARDS OF ARMED FORCES OF PERSONNEL, KILLED/DISABLED IN ACTION DURING PEACE TIME.

Additional seats over and above the sanctioned strength may be created as and when required for the widows /wards of Armed Forces Personnel, killed or disabled in action during peace time, in Institutions under the purview of Ministry of Human Resource Development as per UGC policy.

b. RESERVATION FOR PERSONS WITH DISABILITIES (PWD)

5% seats [Subject to modifications as per the Govt./University of Kerala directives] of the sanctioned strength shall be created, over and above, exclusively for Physically Handicapped candidates in Government/Aided Colleges (as per clause 32(1) of chapter VI, The Rights of Persons with Disabilities Act, 2016). There will be no reservation for the visually challenged for Science Programmes.

As per Clause 2 (r), Chapter I of the Persons with Disabilities Act 2016, "Person with benchmark disability" means a person with not less than 40% of a specified disability where specified disability has not been defined in measurable terms and includes a person with disability where specified disability has been defined in measurable terms, as certified by the certifying authority. Candidates who have a minimum of 40% disability alone will be eligible to apply for this quota. Candidates seeking admission under PWD category should submit the "Certificate of disability", issued not earlier than 5 years prior to the submission of application, by the District Medical Board or bodies of higher status, certifying the degree of percentage of disability. Based on the details furnished in the online application, candidates will be provisionally included under the "Persons with Disability" category.

- The Permanent Disability Card issued by the State Government is also considered.
- The selection of candidates under this category will be based on the rank in the inter-se merit list and physical suitability and not on the basis of the degree of disability.
- No reservation of seat is allowed for Blind candidates for Science subjects.

c. RESERVATION FOR TRANSGENDER CANDIDATES

Two seats shall be created over and above the sanctioned strength in all courses in affiliated Arts & Science Colleges exclusively for admitting Transgender students. (G.O.(Ms)No.153/2018 HEdn dated 03.07.2018). Such candidates should submit transgender identity card issued by the State Government at the time of admission. There will not be any upper age limit for Transgender candidates for admission to any of the programmes in the affiliated Arts and Science Colleges (G.O. (Ms.) No. 295/2021/HEDN dated 07/07/2021).

d. SPECIAL RESERVATION

SPORTS PERSON

Three seats over and above the sanctioned strength, shall be created in each Arts and Commerce subjects and one seats over and above the sanctioned strength, shall be created in each Science subjects for Sports candidates in FYUGP. Admission to such seats shall be made by the Principal, as per the existing procedure for admission under Sports Quota. If the required number of sportspersons is not available, the seats should be kept vacant and shall not be filled by other candidates. (U.O.No. Ac.B1/2004 dated 08- 07-2005). *Refer Annexure 10&10a for more details*

NORMS FOR SELECTION

- Preference shall be given to the sportsperson who has represented at the International level, over National level, over State level, over the sportsperson who has represented the District.
 In the absence of candidates who have represented the State, the Sportsperson with District representation can be considered for filling up the quota.
- The certificate from the Hon. Secretary of the State Association of the concerned event must be produced by the candidate to prove the State representation and from the Hon. Secretary; District Association of the concerned event must be produced by the candidate to prove the representation of the District. (Circular Letter No. Ad.D1.3.1276/74 dated 23-01-1979)
- Approved Association certificate, duly countersigned by the Kerala State Sports Council
 will only be considered for ranking, except two zones Games (Football, Cricket, Volleyball,
 Badminton, Kabaddi) and Athletics & Swimming conducted by University of Kerala.
- Approved Association certificates issued in the valid format only will be accepted.
- The selection of candidates under sports quota is based on their excellence in Sports at Higher Secondary level.
- Selected candidates in the Sports quota are bound to represent the College in the event/game of their specialization during their period of study in the College.
- The above candidates should also register online before the closure of registration. The rank list will be prepared based on the achievement in sports and published separately on the College Notice board and Website. Candidates will be called for interview separately.

All Sports quota applicants should submit the following documents mandatorily at the College Office, Mar Ivanios College (Autonomous) on or before the last date of submission of the online application.

- 1) Hard copy of the online application form.
- 2) Xerox copies of the performance certificates/sports achievement certificates of the last two years.

The above documents listed under 1 & 2 should be enclosed in an envelope and the cover should be superscribed with "Application for Sports Quota". The cover should be submitted to the College Office, Mar Ivanios College (Autonomous), Trivandrum.

The remaining 50% of the seats shall be filled by the management, by candidates of their choice, observing the prescribed eligibility conditions. Candidates who apply under management quota shall also register online.

Note: The fee structure of the Self-financing Courses is higher than that of Aided Courses. Government fee concession is not currently available to candidates enjoying communal reservation, if admitted in Self-Financing Courses.

5.2.5 CLAIMS FOR MANDATORY RESERVATION AND CERTIFICATES TO BE PRODUCED

o Claims for Mandatory Reservations must be made by a candidate at the time of submission

- Personal and Academic Data Sheet. They should also satisfy the eligibility conditions as per the Prospectus at the time of online registration.
- O Candidates should produce all original documents to prove their claims made in the online application form at the time of admission before the Principal. Claims that are not mentioned at the time of online submission of application will not be entertained even if supporting evidences are produced later on. The claims for mandatory reservation once made cannot be altered by the candidate under any circumstances.
- There is no Communal reservation under 'Socially and Educationally Backward Classes' (SEBC) / OBC/OEC.

Claim for Reservation under Scheduled Castes/Scheduled Tribes quota

- Candidates claiming reservation under Scheduled Castes/ Scheduled Tribes quota should obtain the caste/community certificate from the Village Officer/Tahsildar. For list of SC/ST see Annexures 3 and 4.
- Warning: Those who produce false SC/ST Certificate for claiming reservation under SC/ST quota shall be liable for penalties as per rules.
- The seats unavailed by the SC candidates will go to ST candidates and vice versa.

Claim of SEBC candidates against the unavailed seats of SC/ST candidates.

- Socially and Educationally Backward Classes (SEBC) candidates who claim allotment to
 the un-availed seats, if any, under SC/ST quota should furnish community and income
 certificates obtained from the Village Officer/ Tahsildar. SEBC candidates who possess
 'Non Creamy layer Certificate' obtained from the Village officer/Tahsildar concerned alone
 are eligible for such seats.
- Converted Christians do not come under the SC/ST category. They belong to OEC category.
 Refer Annexure 4.

GENERAL RULE FOR MANDATORY RESERVATION

If sufficient candidates are not available for filling the seats reserved for SC/ST candidates, such seats will be filled as per Govt. / University rules.

5.3 RULES FOR ADMISSION OF STUDENTS TO VARIOUS FYUG PROGRAMMES- Eligibility, Ranking and Weightage

5.3.2 ASSESSMENT OF MERIT

Except when otherwise provided, the merit of a candidate will be assessed on the basis of the marks obtained by him/her in the qualifying examinations for admission to the particular course, subject to such criteria as may be prescribed by the University. In assessing merit, marks will be

awarded for extracurricular activities like sports, NCC, NSS of the students. These marks will be added to the marks obtained for the qualifying examination for preparing the rank list.

5.3.3 Weightage of marks for N.C.C./ N.S.S. Certificate holders/Ex-servicemen/ Dependents of Ex-service men and Jawans

In assessing merit, marks will be awarded for extracurricular activities like NCC, NSS and Student Police Cadet (SPC) of the students and also to Ex-servicemen / widows or children of Jawans and Ex-servicemen. These marks will be added to the marks obtained for the qualifying examination for preparing the rank list. The weightage of bonus marks shall be added to the marks scored by the candidate either to make him/her eligible for admission to a Programme or for ranking purposes to those who are otherwise eligible for admission. In the case of candidates who get the eligibility by this bonus marks, their ranking mark will be the sum of scored marks and the bonus marks.

Weightage of marks for NCC / NSS / SPC/ Scout and Guides certificate holders

A weightage of 15 marks will be given to NCC / NSS / SPC (Student Police Cadet)/ Scout and Guides certificate holders for the purpose of ranking.

- For awarding bonus mark to NCC/ NSS/ SPC the certificate signed by the Competent Authority shall be submitted.
 - For awarding bonus mark to Scout and Guides, the certificate signed by the Competent Authority shall be submitted.(Only Rajyapuraskar & Nanmamudra Certificates are accepted)

The candidates who have attended NSS / NCC / SPC / Scout and Guides during the academic year of the qualifying examinations ie, plus two only will be eligible for the bonus mark.

Note:

- a) In respect of candidates who want to avail bonus marks for NCC, the marks will be awarded on the basis of NCC Weightage Certificates signed by the Director and issued by the Directorate of NCC to the candidates who have secured at least 75% of attendance after having participated in its activities during the course of study immediately preceding the course for which admission is sought.
- b) For awarding bonus marks to NSS participants, the basis will be NSS certificates signed by the Competent Authority.
- c) For awarding bonus mark to SPC, the certificate signed by the Competent Authority shall be submitted.
- d) The benefit of bonus marks for purposes of admission can be earned by the candidates only under any one category (either NSS or NCC or SPC).

Weightage of marks for Ex-servicemen/ widows or children of Jawans and Ex-servicemen

A weightage of 15 marks will be given to the Ex-servicemen / widows or children of Jawans and Ex-servicemen for admission. (U.O. No. Ac.B.3/Misc./73 dated 30-10-1974). (Academic Council dated 28-08-1974). (Applicable to Army/ Navy/ Air force only. Not applicable to paramilitary forces/ CAPF/ GREF/ Coast Guard etc.)

To avail the weightage of bonus mark under the category "Ex-servicemen / widows or children of Jawans and Ex-servicemen", the candidates should invariably produce an attested copy of certificate issued not earlier than six months from the last date of submission of application, from the military authorities or State/Zilla Sainik Welfare Officer to the effect that he/she is the son/daughter/widow of a Jawan / Ex-service man or an Ex-service man himself/herself.

5.3.5 STANDARDIZATION OF MARKS FOR ADMISSION TO FYUG PROGRAMME – GUIDELINES ISSUED (2010-2011 ONWARDS).

Calculation of Index Marks for Higher Secondary students from 2010 onwards:

Index Marks = Total marks secured for Higher Secondary+ Marks secured in the concerned subject.

- For e.g. If the student has secured 800 marks out of the total 1200 marks and if s/he has secured 150 out of 200 in mathematics, his/her index marks will be 800 + 150 = 950.
- In the case of admission to B.A English, double the percentage of marks obtained for English are added to the total mark.
- If the student in the above example has secured 120 marks out of 200 in English, his/ her index mark will be 800 +120 =920

Calculation of Index Marks for Higher Secondary students prior to 2010:

Index Marks=Marks out of 600 normalized to 1200 + twice the marks secured in the concerned subject

- For e.g. If the student has secured 400 marks out of the total 600 marks and if he has secured
 75 out of 100 in Mathematics, his index marks will be 800 + 150 = 950.
- If the student in the above example has secured 60 marks out of 100 in English, his index mark will be 800 + 120 = 920

Calculation of Index Marks for VHSE students:

Exclude the marks of the Vocational and Foundation course and normalize to 1200.

From 2010 onwards:

For VHSE from 2010 onwards, English was out of 200 and Optionals 1, 2 & 3 were out of 200 each, for a total of 800.

Normalize as follows:

Step 1: Normalize English marks to 400; Step 2: Normalize Optionals to 800.

- If a student scored 150/200 for English and 500/600 for the three Optionals, Index marks/1200 = (150x2) + (500/600x800) = 300 + 666.66 = 966.66
- The Index Marks for FDP in English=Index Marks = Marks in English out of 200=966.66+150=1116.66

Prior to 2010:

Prior to 2010, VHSE marks for English were out of 100, and the three optional had 100 marks each, for a total of 400.

Normalize as follows:

Step 1: Normalize English marks to 200; Step 2: Normalize Optionals to 400.

Step 3: Double the marks out of 600 to get the Index Marks out of 1200.

- If a student scored 60/100 for English and 200/300 for the three optionals, Index Mark/1200= $2x\{(60x2)+(200/300x400)\}=2x(120+266.66)=2x386.66=773.32$
- Index mark for FDP in English would be 773.32+120= 893.32

Calculation of Index Marks for CBSE/ ISC and other Boards:

Normalize total marks obtained to 1200, add double the percentage obtained for the concerned subject.

- If a CBSE student scored a total of 400/500 and 80/100 for Mathematics, Index Mark for FDP in Mathematics would be (400/500x1200)+(80x2)=960+160=1120
- If the same student scored 70/100 in English, Index Marks for FDP in English would be 960+140=1100

5.3.6 LOSING OF MARKS DUE TO SUBSEQUENT APPEARANCE

Candidates will lose 10 marks for ranking purpose for each additional appearance he/she has taken for completing the qualifying examination.

5.3.7 RESOLVING OF TIE IN INDEX MARKS

In case of a tie in index marks deciding admission, the following criteria will be considered in decreasing priority:

- i. Marks of the subject opted;
- ii. Marks in English
- iii. Date of birth(older be placed higher in ranking)
- iv. Name of the candidate (Alphabetical order)

5.3.8 DEDUCTION OF MARKS

Candidates will lose 10 marks from the total ranking marks for each additional appearance he/she has taken for completing the qualifying examination.

5.4 SUPPLEMENTARY NOTES:

5.4.2 FOR ADMISSION TO FYUG PROGRAMMES

The Candidates who have passed qualifying exam under ISC or any other boards which have
more than three electives will have to submit more than one application with different
electives, in case they wish to seek admission for all the electives they have studied.

For example, if a candidate who has studied Mathematics, Physics, Chemistry and Biology

as electives and wish to apply for B.Sc. Mathematics should compulsorily enter the marks of Mathematics plus the marks of any other two electives (say Physics and Chemistry) as per their choice of that stream. If this candidate wishes to apply for B.Sc. Botany or B.Sc. Zoology, he/she will have to submit separate applications with separate registration fee.

- For subjects which are not being offered at the qualifying Examination level, the marks of
 related subject or subjects, acknowledge of which is essential for the study of the subject
 proposed to be chosen for the FYUGP, shall be added to the total marks for the purpose of
 ranking.
- Candidates with CHANCE MEMO who did not get admission will be put in a new list of CHANCE MEMO candidates. They will be called for the Admission Interview in the event of any vacancy arising in their chosen programme (due to issue of T.C, etc)

5.4.3 Joining for a UG course after Cancellation of a course

Candidates undergoing various courses in the University or who have registered/appeared for any of the degree examinations of the University in regular mode are permitted to cancel registration/examination for the purpose of joining for the same course in the University in regular mode, as a one-time provision, only under any of the exigent circumstances as detailed below.

- a. Issues in the college where he/she has pursued the curse (like ragging, issues with college authorities/ other students etc)
- b. Distance from home town.
- c. Non availability of college hostel.
- d. Death or serious illness of parents/supporting guardian.
- e. Illness of the candidate causing disability/serious illness of the candidate.
- f. Difficulty to commute due to accident, surgery etc.
- g. Difficulty to continue studies due to financial crises in the family.

Candidates who have cancelled a programme from the Kerala University or any other Universities and joining for any UG programme in Mar Ivanios College (Autonomous) should submit cancellation memo of the previous programme/course (from the concerned University/College) at the time of admission at Mar Ivanios College (Autonomous).

6. SPECIAL NOTICE ON RAGGING AS A CRIMINAL OFFENCE 6.2 PREVENTION OF RAGGING

Ragging is prohibited by law and is totally banned in the College. It is a criminal offence and anyone found guilty of ragging and/or abetting ragging is liable to be punished appropriately as per law/ UGC guidelines.

6.3 RAGGING: DEFINITION "Ragging" means the following:

"Any conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or un-disciplined activities which causes or is likely to cause annoyance, hardship or psycho-logical harm or to raise

fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student."

EXCERPTS FROM THE UGC REGULATION ON CURBING THE MENACE OF RAGGING IN HIGHER EDUCATIONAL INSTITUTIONS 2009 NO. F.1- 16/2007 (CPP-II) DT.13 APRIL 2009; NO.F.15-3/2013(ARC) PT.ILL DT 25 DE- CEMBER 2013 (SECOND AMENDMENT); NO. F. 1-15-/2009 (ARC) DT 29TH JUNE, 2016 -(THIRDAMENDMENT)

Ragging in all its forms is prohibited in the College Campus, including the departments, all its premises (academic residential, sports, canteen restrooms etc), within the campus or outside it and all means of transportation whether public or private. The provisions of the Act of the Central Government and the State Governments if enacted will consider ragging as a cognizable offence under the law on a par with rape and other atrocities against women and ill-treatment of persons belonging to the SC/ST.

Students shall not indulge in any of the following activities, which are treated as ragging (Clause 3 of UGC Regulations): Ragging constitutes one or more of any of the following acts:

- Any conduct by any student or students whether by words spoken or written or by an act
 which has the effect of teasing, treating or handling with rudeness a fresher or any other
 student;
- Indulging in rowdy or indisciplined activities by any student or students which causes or likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;
- Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.;
- Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher;
- Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students;
- Any act of financial extortion or forceful expenditure burden put on a fresher or any other students by students;
- Any act of physical abuse including all variants of it: sexual abuse, homo- sexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
- Any act of abuse by spoken words, e-mails, post, public insults which would also include
 deriving perverted pleasure, vicarious or sadistic thrill from actively or passively
 participating in the discomfiture to fresher or any other student;
- Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or

superiority by a student over any fresher or any other student.

 Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of colour, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background.

6.4 Reporting cases of ragging:

The complaints or information in regard to ragging could be oral or written and even from third parties. The burden/responsibility of proving his/her innocence rests with the accused and not with the victim. Complaints can be lodged with the Principal, Staff Counsellors or any of the members of the Ragging Prevention Committee. All complaints / information received shall be kept strictly confidential. In the event of a student being booked in a criminal offence and being suspended from the college, he / she will be re-instated only after his/her obtaining clearance certificate from the concerned police officer.

Punishable Ingredients of Ragging:

On receipt of the recommendation of the Anti Ragging Squad or on receipt of any information concerning any reported incident of ragging, the Principal shall immediately determine if a case under the penal laws is made out and if so, either on his own or through a member of the Anti-Ragging Committee authorised by him in this behalf, proceed to file a First Information Report (FIR), within twenty four hours of receipt of such information or recommendation, with the police and local authorities, under the appropriate penal provisions relating to all offences following from the definition of "Ragging".

Students are directed to report any incident of ragging forthwith to the respective Faculty Advisor of the Class or any member of the Anti-Ragging Committee or the Head of the Department or the Principal. For Ragging Complaints at the UGC level: Toll Free No.: 1800 - 180 - 5522; E-mail: helpline@antiragging.in. UGC monitoring agency: 09871170303; 09818400116 (only in cases of emergency).

6.5 Punishments:

At the Institution Level:

Depending upon the nature and gravity of the offence as established bythe Anti Ragging Committee of the Institution, the possible punishments for those found guilty of ragging at the Institution Level shall be anyone or any combination of the following:

- 1. Suspension from attending classes and academic privileges.
- 2. Withholding/withdrawing scholarship/fellowship and other benefits.
- 3. Debarring from appearing in any test / examination or other evaluation process.
- 4. Withholding results.
- 5. Debarring from representing the Institution in any regional, national or international meet, tournament, youth festival, etc.
- 6. Suspension/ expulsion from the hostel

- 7. Cancellation of admission.
- 8. Rustication from the Institution for period ranging from one to four semesters.
- 9. Expulsion from the Institution and consequent debarring from admission to any other institution for a specified period.
- 10. Fine ranging between Rupees 25,000/- and Rupees 1 lakh.
- 11. Collective punishment: When the persons committing or abetting the crime of ragging are not identified, the Institution shall resort to collective punishment.

7. GENERAL RULES OF THE COLLEGE

- All the students are compulsorily required to have their identity card with them while they are
 on the campus and should wear the same around their neck. Identity cards will be issued by
 the College at the time of admission. Wearing of identity tag in College is mandatory as per
 Government Order G.O.No.26483/ G1/15/H.Edn dated 12.10.2015.
- Students should keep all the receipts obtained from the college safely and should produce them for verification if required.
- Caution deposit of a student will be refunded only on surrendering the original receipt of the remittance.
- Students admitted to the college should strictly abide by the rules and regulations of the College.
- The College works under the full day system from 9:30 am to 3:30 pm (subject to periodic Government / University directions. Besides lecture classes there will be Seminars, Tutorials, Club/ Extension activities, Group Discussions, Counselling and Life Orientation Programmes.
- At the beginning of the morning session before the commencement of classes, there will be a
 bell, the first bell, when students should go to their respective classes and occupy their seats.

 Every day the classes shall begin with a prayer song. When the bell for the prayer song, the
 second bell, is heard, all students shall stand up; those still moving around outside class shall
 stand still in their place in prayerful attitude.
- 75% aggregate attendance for all the courses in a semester is mandatory for a student to be eligible to register for the respective End Semester Examination. Those who fail to secure there quire attendance will not be allowed to register for the End Semester Examination and shall have to discontinue. Parents should makes sure that their children attend classes regularly.
- Students who intend to avail any kind of leave, other than emergency leave, shall inform and get prior permission of the Faculty Advisor for the same; they shall apply for leave in the prescribed Leave Application Form which is available in the College Website/CMS Mobile App. No duty leave will be permitted without prior application.

- If a student is found to have indulged in ragging, strict action will be taken against that student. (vide Hon'ble Supreme Court Order No.SAP(c)No. 24295/2004). Smoking/ chewing, use of tobacco, pan parag, drugs, alcohol, and all such products that are either banned, illicit or injurious to health, are strictly prohibited inside the College campus. Nobody shall enter the college campus after ingesting alcohol/drugs or under intoxication.
- The Malankara Syrian Catholic Colleges Corporate Management bans politics in colleges under the Management, based on the verdict of Division Bench of Hon. High Court of Kerala. The Management prohibits political activities in college campuses and forbids students from organising or attending meetings other than official ones within the Colleges. (Vide-Circular No. Msc-25/2003/Genl. dtd 23.06.2003, Secretary, MSC Colleges)
- All political and organisational activities are strictly prohibited in the campus. Students'
 organisations are not recognised by the College authorities. Their requests or demands shall
 not be entertained. However, those organisations that are complementary to the academic
 pursuit can be permitted by the Principal.
- Use of mobile phone is restricted inside College Campus; they shall be switched off before
 entering the campus. Mobile phones with camera are banned inside College campus by the
 State Government (vide Government of Kerala Rt. No. 1102/05/H.Edn). In the event of any
 violation of the above, action will be taken including confiscation of the device and imposition
 of fine.
- Nobody shall disrupt the academic atmosphere of the College under any circumstances. Any
 such activities that may hamper the academic ambience of the institution will be seriously dealt
 with. Such misconduct would entail major punishment including expulsion from College. If
 necessary, criminal prosecution also will be invoked.
- Destruction of College properties would entail civil as well as criminal proceedings against delinquents.
- Nobody shall instigate or engage in activities such as strike, demonstration, agitation, slogan shouting etc. within the College campus.
- College Union election will be conducted under indirect mode /parliamentary system. No
 external or political interference shall be permitted. (WP (C) No.24335 of 2014(N) at the Hon.
 High Court of Kerala)
- All legal and reasonable grievances of the students will be addressed by the College authorities.
 In the event of any such grievance, the aggrieved can approach the respective Faculty Advisor or the Students' Grievances Redressal Committees existing in the College. The decision of the Principal shall be final.

- Parents/Guardians are earnestly directed to make sure that their children abide by all the rules and regulations of the College. Parents should give their correct contact details at the time of admission. Apart from compulsorily coming to the college on request from the respective authorities on matters of necessity, parents should also make it a practice to meet teachers and authorities often to assess the progress of their wards. There shall be Parents' Meeting/ Open Houses at least once a semester as a matter of practice.
- Students have to strictly abide by the dress code of the College. The college does not insist on
 uniform dress for students, but decency, modesty and decorum in attire is expected from all
 students. Students are expected to wear clothes that contribute to the academic atmosphere
 necessary and appropriate to an Indian College Campus.
- Students are strictly warned against loitering outside classrooms or just outside the campus during class hours. They shall either remain in class or spend their time in the library.
- Students are prohibited from bringing their four wheelers to the campus. Those students who come on two wheelers should necessarily wear helmet in and outside the campus. Such students should obtain a Vehicle Pass from the College Office which will be issued only after submitting a proper application which carries the Parent's consent and an affidavit that they will obey all motor vehicle rules and regulations and road safety measures including wearing of the helmet. Copy of the valid driving license should be attached with the application for Vehicle Pass. Not more than two persons shall travel in two-wheelers. Two wheelers should be parked in the parking area assigned by the management. Students shall in no case take their vehicles inside the College gates.
- The College offers personal mentoring for students. One teacher mentor is assigned to every 20 students. The mentor is a guide, friend, and philosopher for the students on the campus. Apart from teacher mentors, there is a full time professional Counselling Psychologist in the College. Students are directed to seek the assistance of mentors and counselor if and when needed. Parents are also requested to contact the counseling psychologist for any needs of their children. Candidates (and their parents/ guardians) are expected to be aware of, and follow, all the rules and regulations of the College.



Admission to Management Quota (MQ) - Regulation/Policy

- 1. Only those students with more than 70% marks in the qualifying examinations (Plus II) will be considered for admission under MQ (for Degree) and 60 % (for PG)
- 2. Students with break in studies will not be given admission in MQ quota.
- 3. NRI students will be given MQ admission only if some close relative/guardian or family takes full responsibility and guardianship.
- 4. There will be due weightage for catechism certificate of XII/ X Class, MCYM and Church activities for the Community students (Malankara Syrian Catholic) to MQ.
- 5. It is obligatory for Community students to have Catechism X Standard pass certificate for MQ admission. They should attend all spiritual activities, liturgical services including the Holy Qurbono, Jesus Youth etc. decided by the authorities of the College/Hostel.
- 6. Community students seeking admission under MQ from outside Kerala should produce recommendation letter from concerned Malankara Syrian Catholic parish priests.
- 7. The one who recommends the candidate to MQ will be responsible for the conduct of the student. This will be applicable for all those who make a recommendation (including all those who are in the ecclesiastical as well as political and other spheres).
- 8. Candidate seeking admission under Management Quota should register online in Management quota.
