2. The total SCPA/Mark secured by each successful candidate is shown along with the Register number of the candidate.
3. In the case of First Degree Programme under CBCSS and CSS, for the successful completion of a Semester, a candidate has to score a minimum SCPA of 4.00 (E Grade). A minimum of 40% marks (E Grade) is required for passing a course with a separate minimum of 35% (E Grade) for End Semester Evaluation (ESE) and for Continuous Evaluation (CE) for 2018 Admission.
4. In the case of Post Graduate Examination for successful completion of a semester, a candidate shall secure a minimum of 40% marks for ESE and 50% marks for CE and ESE

together for each subject in the semester for candidates belonging to 2015 Admission onwards.

5. The draft Statement of Marks will be obtained from the College Website shortly.
6. **Candidates who desire to apply for Revaluation/Scrutiny shall submit application and remit fees Online through Students Login. The Online registration shall be open from 17th March to 7th April 2021.** No Revaluation is applicable for P.G. Degree Courses.
7. Students who apply for scrutiny are eligible to apply for revaluation of that answer scripts within 5 days from the date of scrutiny of their answer scripts.
8. The prescribed fee is **Rs. 500/- per paper for Revaluation, Rs. 100/- per paper for Scrutiny along with Rs. 30/- for Online registration.**
