Mar Ivanios College, since its inception under the percipient guidance of Servant of God Archbishop Mar Ivanios in 1949 has been an institution of distinction in providing quality education. The College is one of the Malankara Syrian Catholic Colleges established and administered by the Major Archdiocese of Trivandrum in accordance with the rights of the minority community guaranteed in the Constitution of India. Mar Ivanios College is the first Institution in the University of Kerala to receive accreditation from the National Assessment and Accreditation Council (NAAC) in 1999 and also to be re-assessed and re-accredited with 'A' Grade in the subsequent evaluations. The college is now reaccredited with NAAC A++ in the 5th cycle in 2024. The college has completed the fourth cycle of accreditation in 2019. Mar Ivanios College is the first private college affiliated to the University of Kerala to receive the status of CPE (College with Potential for Excellence) from the UGC in 2004 and the same was extended in 2014. The College has been conferred with Autonomy status by the UGC from 13th June 2014. Mar Ivanios College bagged 36th position in the National Institutional Ranking Framework (NIRF) 2018 among the category of Arts and Science Colleges and is maintaining its position among the top 50 colleges for four consecutive years. CALL FOR PAPERS

Authors are invited to submit their original and unpublished manuscripts based on research, experiences, value-based decision making or promising ideas that demonstrate research focusing on a variety of aspects needed to achieve strategies for excellence.

SUBMISSION GUIDELINES

- Authors should submit their original and unpublished papers in word format.
- The manuscript should not be under the process of publication or should not have been submitted to any journal.
- Abstract of not more than 300 words and 5-7 keywords bearing the author's name (s), contact details and e-mail id(s). It must indicate study period, sample, research question, methodology, findings and implications.
- E-mail your abstract and papers to icebm@mic.ac.in.
- Full paper should have a separate cover page bearing only the title of the paper and author's name(s), designation(s) and official address(es) along with phone number and e-mail address.
- Full paper should be between 3000 and 5000 words (all-inclusive) and APA format (Times New Roman, I2pt, 1.5 line spacing on A4 layout with standard margins (2.54 cm on all four sides) should be followed throughout the manuscript.
- Authors will be notified about the acceptance of their paper(s) for presentation through email, after which the process of registration will begin.
- Registration will be confirmed only after the payment of the registration fee and at least one author must be present for the conference and paper presentation.
- Presentation can be done in both online and offline mode
- Registration form is available on the college website.
- Co-authors are required to register and make the payment separately for attending the conference and to get a presentation/participation certificate.

PUBLICATION OPPORTUNITY

- Selected papers will be invited for review and potential publication in the proposed peer-reviewed journal of Mar Ivanios College, "Innovatus; An Ivanian Journal for Economics and Business Studies" and in an edited book with ISBN.
- The best paper Award will be presented to the most outstanding submission


